1. EXECUTIVE SUMMARY

North West Anglia NHSFT (and formerly Peterborough and Stamford NHSFT) has enjoyed a longstanding relationship regarding education of medical students from the University of Leicester. The achievement of Associated University status would further formalise the links and add to the profile and reputation of the Trust. Once the Associated University Status has been achieved, there is a plan to work towards University status. The current work-streams are:

- Acceptance of increased numbers of medical students
- Acceptance of increased numbers of non-medical students (nursing, midwifery and allied health professionals)
- Expansion of research portfolio – jointly and independently

- 1.1 If the Board gives approval to the Chief Executive Officer to sign the Strategic Partnership Agreement, the agreement will be forwarded to the University of Leicester for ratification and thereafter the status can be conferred.
- 1.2 The benefit to the Trust is the expected enhancement of its profile and attractiveness to both clinical and non-clinical staff leading to their recruitment and retention.
- 1.3 There is no risk to non-approval; the status quo will pertain. There is no downside risk to approval as the Trust will be expected to educate increased numbers of medical students a part of a national initiative. Funding will follow the increased numbers of students. There are no quality risks. The enhanced research activity will improve the quality of patient care.
- 1.4 The Trust also has parallel medical educational links with Cambridge University but this university does not offer Associated University Status. It is, however, at North West Anglia NHSFT's request changing its constitution to confer Teaching Partner status.
